PASTORAL SCHEME

This Scheme is made by the Church Commissioners this 23rd day of April 2013 in pursuance of the Mission and Pastoral Measure 2011, the Right Reverend Michael, Bishop of Exeter, having consented thereto.

Dissolution of parish

1. The parish of Ringmore with Kingston, being a parish within the area of the benefice of Modbury, Bigbury, Ringmore with Kingston, Aveton Gifford, Woodleigh, Loddiswell and East Allington in the diocese of Exeter, shall be dissolved.

Creation of new parish of Kingston

2. (1) A new parish which shall be named "The Parish of Kingston" shall be created within the area of the benefice of Modbury, Bigbury, Ringmore with Kingston, Aveton Gifford, Woodleigh, Loddiswell and East Allington in the diocese of Exeter, and the area of the new parish shall be all that part of the parish of Ringmore with Kingston which is stippled and lettered "A" on the annexed map.

(2) The church of Saint James the Less within the area of the new parish, which church has been approved by the Bishop, after consultation with the Exeter Diocesan Advisory Committee and the Exeter Diocesan Pastoral Committee, as suitable to be a parish church and has been consecrated, shall be the parish church of the new parish.

(3) The new parish shall belong to the archdeaconry of Totnes and the deanery of Woodleigh.

Creation of new parish of Ringmore

3. (1) A new parish which shall be named "The Parish of Ringmore" shall be created within the area of the benefice of Modbury, Bigbury, Ringmore with Kingston, Aveton Gifford, Woodleigh, Loddiswell and East Allington in the diocese of Exeter, and the area of the new parish shall be all that part of the parish of Ringmore with Kingston which is stippled and lettered "B" on the annexed map.

(2) The church of All Hallows, being the parish church of the parish of Ringmore with Kingston, shall be the parish church of the new parish.

(3) The new parish shall belong to the archdeaconry of Totnes and the deanery of Woodleigh.

Alteration of name of benefice

4. The name of the benefice of Modbury, Bigbury, Ringmore with Kingston, Aveton Gifford, Woodleigh, Loddiswell and East Allington shall be altered to "The Benefice of Modbury, Bigbury, Ringmore, Kingston, Aveton Gifford, Woodleigh, Loddiswell, and East Allington".

Coming into operation of this Scheme

5. This Scheme shall come into operation upon the first day of the month following the date of it being made by the Church Commissioners.

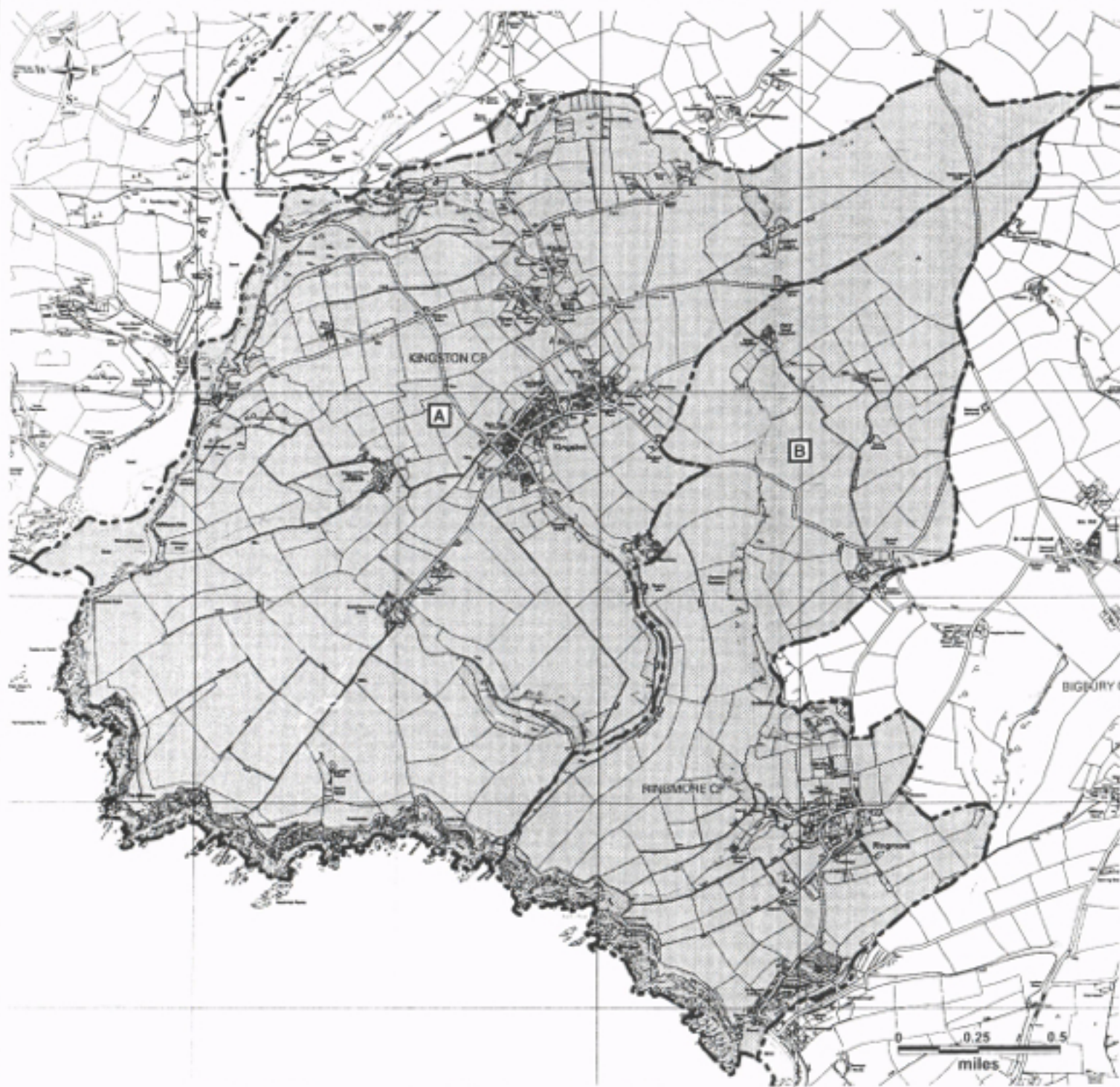
