TO SECURE THE SUM OF £1670 balance of purchase money due to the 1st by the 2nd Parties, the 1st parties have granted to William Longueville two messuages called "Langstones" in Ringmore Co. Devon, Great and Little Octenburys, and certain rents in Ringmore & Totnes for a term of 99 years on condition that if the said some of money be paid on 21 Dec. 1690 such grant shall be null and void.

By virtue of lease 17 day of May 1806 : Henry Roe to Samuel Perriton £12-10 : 99 years on lives Sarah Perriton and William Perriton...Cottage or Dwelling House with the Hogsties & Garden Plot lying behind and near the same only divided only by a path. 9 Perches of ground...3 ground rooms & 2 chambers formerly in possession of Thomas Coker and others afterwards of Rachel Symons widow of the said Samuel Perriton afterwards of John and 7Robt. Perriton or their tenants but now of the said Thomas Randle heretofore part of a tenement called Mary Skinner's half farthing. 99 years on death of Sarah Perriton and William Perriton

£ 24 ten days ; £10 two for three days Strongly recommend regular tuning service twice per annum for 50/- per annum. Should this be beyond the financial capabilities of the Church, then at least visit per annum at a cost of 25/-. Hele and Company, London 14 Jan 1931
